Commodore

N Glossop reported new opening times for food service, with no service on Sundays but members invited to bring their own picnics. He is organising annual appraisals for the club staff. He requested that the Honorary Treasurer investigate ways of organising staff tips using card payments.

D Brandreth reported that he is making sure that records are up to date and will speak to those manning the Committee boat to clarify procedures.

Rear Commodore Amenities

E Bolitho reported that ongoing maintenance of the pontoon continues.

Honorary Secretary

P Lethfead –Currie reported that new flags had been purchased and were now in use.

Honorary Treasurer

M Lowe reported that the balance in the clubs accounts stands at £111,089 after £30,000 has been set aside for the pontoon fund and although there are a number of creditors to be paid and that the clubs balance exceeds that of last year at the same point. A bar stock take was carried out earlier this day and will be repeated in three months time. Documents explaining profit margins were presented to the Committee members. He expressed concerns over kitchen cleanliness and N Glossop will take the necessary action. Replying to a question regarding insurance, M Lowe had spoken with the clubs insurers re pontoon survey requirements but they had declined to give any specific details of their requirements.
