## **Minutes of Last Meeting**

#### Commodore

He has received a letter from John Head concerning the pontoon: Ladder needs replacing end of easterly pontoon, sign erected by water hose asking to leave space for visiting yachts, provide goods trolley, like those available in French Marinas at base of pontoon. #### **Honorary Treasurer**

Peter Watson has reported that the cash at bank was £55,486.21. End of year net proceeds were £59,760.70.

The predicted net profit after end of year adjustments and depreciation of assets is expected to be approximately £41,000. This will be agreed after a meeting with our accountants and is dependent upon further write downs of capital items.

All tax calculations at HRSC are now MTD ready.

In our report to HMRC, HRSC requested that our VAT de-minimus threshold should be increased to a more realistic figure as the threshold had not changed for almost 40 years.

That in coming years it is important to build up our liquidity and reserves for the pontoon etc.

That as costs across the board were increasing, it is recommended that some membership and mooring fees should be increased in line with inflation next year. This was agreed.

#### **Captain Yachts**

Ollie Berryman reported that Rob Hewett has resigned as Chair of L'Aber'wrach Committee. Ollie has volunteered to step in. Ollie would like to have a L'Aber'wrach fundraising raffle as it was very successful this year. Ollie plans to approach Champagne Company to sponsor the event. He hopes to increase number of entrants. This year there was a problem with declaration cards not being handed in on time. It was suggested we could set up a website and enter name, sail number, and finish time.
