Minutes of Last Meeting

Commodore

John Bolitho welcomed the new members of the Committee and expressed optimism for the forthcoming year.

Vice Commodore

Angie Watson reported that she had attended a meeting with the trustees who had expressed satisfaction with the financial planning for the forthcoming financial year. They had raised the subject of payment of membership fees by direct debit as per Club rules 16. This was discussed by the Committee and it was agreed that this rule should continue to be enforced. She reported that the new stewards had now taken over the running of the restaurant and bar and that they had appointed Megan as bar manager. She will now attend the house meetings. A new card payment company has been engaged at a substantial saving. Cost control measures for the next year had been devised with the Honorary Treasurer and these were outlined to the Committee.

Rear Commodore Sailing

Chris Hosken reported that he will meet the Club Captains shortly to plan activities for the season. He has conducted a review of the sustainability of the Club rescue boats and it has been decided that they will meet the Club's needs for the next sailing season. The results of this survey will be circulated to the Committee. He is negotiating for the Club to have two Fusion dinghies on demonstration for the season.

Honorary Treasurer

John Lake announced that the Club's current account balance is £80,033.04 and the deposit balance is £13,769.50. He outlined cost forecasts for the next year and explained budget restructuring.

Peter Lethfead-Currie reported that he had attended a Falmouth Bay Secretaries meeting to discuss the new Data Protection Act. He will implement measures to ensure that we comply.

Dom Brandreth is working on plans to promote keelboat sailing for the forthcoming season.

Stephen Brooks announced that he is planning a joint regatta with St.Mawes SC and the HRCST to take place in May.
