It was proposed by Simon Drakeley and seconded by Daniella Wilson that the minutes of the Committee meeting held on Monday 5th February 2018 be adopted as a true and accurate record. All in favour.

Honorary Treasurer

John Lake invited discussion that we increase the sum insured by our public liability insurance to £10 million. This was proposed by Simon Drakeley and seconded by Nick Glossop and passed unanimously. He reported on the recent discussion with the Club's insurance broker. He informed the

Committee of the Club Officer's responsibility to act in accordance with guidelines for safety issued by the various water activity governing bodies. Some evidence that this was being carried out may be required by our insurers in the event of a claim being made against the Club. The facility for non-members to launch from the Club premises upon payment of a launch fee will no longer be available as the Club is not insured for this.

The Club's current account balance stands at £75,562.26 and the deposit account is £13,769.61. The new till is now in use and is providing cost control benefits.

Peter Lethfead-Currie reported that he had been in contact with the RYA Data Protection Officer and that she was satisfied that the Club was meeting all requirements of the new legislation. In view of the new laws he invited Committee members to indicate their preferences for their personal details to be displayed in the new yearbook.

He informed members that an approach had been made by the Porto Montenegro Yacht Club for a reciprocal arrangement to be made for Club Members.
